The last garden tour (2018) expenses/income/profit amounts are not readily available for comparison. 2016 garden tour: expenses \$2,078 / income \$8360 / profit \$6282. \$35K in the bank.

Garden leads budget will be raised approx 20%.

Damage budget will be raised to \$1000.

Speakers will be estimated at 8 x \$100.

Janice will ask Louise how much was brought in from the Evergreen Art Gallery event.

Helen will have the full report ready to be distributed before the October meeting so that we can vote on it.

Helen will be prepared to process new membership and renewal applications with the ability to pay cash, check or credit card at the meeting.
